**Correction of Error on Birth Certificate**

This instrument is executed in accordance with the Provision of Section 38 (2) of the Registration of Births and Deaths Act, Chapter 157 of the Laws of Belize R.E. 2000

Except for signatures, please **PRINT ALL** information in **BLACK CAPITAL LETTERS**.

A Statutory Declaration is to be made on the prescribed form by a qualified person, stating the nature of the error to be corrected, and the cause of the delay in having the correction made. The declaration is to be signed in the presence of a Justice of the Peace. If the Declarant resides **OUTSIDE OF THE COUNTRY OF BELIZE**, the declaration is to be signed in the presence of a Notary Public.

A Baptismal Record must be obtained and a certified copy of the Birth Certificate must be obtained also.

The sum of \$3.00 is payable for each correction requested and the cost of a new Birth Certificate is \$3.00 Each declaration carries a \$1.50 stamp. The processing time is one week
